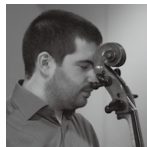

Rules and Regulations

Music is called the universal language that touches the hearts of all ages. The Japan Chamber Music Foundation was established in 1992 to enhance the appeal of chamber music, described as the origin of music. It organized the first Osaka International Chamber Music Competition the following year. Since then, we have continued to hold this musical event every three years which produced many talented chamber music ensembles.

Devoted young ensembles will be invited from across the world to take part in the Chamber Music Competition. Prizes will be awarded to the outstanding ensembles selected by a group of internationally renowned musicians who are authorized by the foundation to serve as the jury. In the Competition, Section I features String Quartet, while Section II focuses on Piano Trio and Piano Quartet.

The Chamber Music Festa is open to all music genres from classical to ethnic or traditional music and has no restrictions on age or types of musical instruments. This unique style enables the audience to experience the joy and diversity of chamber music.

We hope that all the ensembles will be able to show the fruits of their work, prove their versatility and develop their musical talents. We believe this event will encourage local audiences and international musicians to interact with each other.

1.1 Performance Categories

The Competition comprises the following two categories:

Section I : String Quartet (Two Violins, Viola and Cello)

Section II : Piano Trio (Piano, Violin and Cello) or Piano Quartet (Piano, Violin, Viola and Cello)

1.2 Selection Rounds

The Competition will be judged at the 1st, 2nd, 3rd (only for Section I) and Final Rounds.

1.5 Copyrights

The Organizer shall have the rights to record, photograph, broadcast and stream any stage of the event, as well as all rights regarding production, sales, etc. of CDs and/or DVDs.

And the Organizer shall have the rights to use any application materials from applicants such as photograph, profile and performance video for the purpose of promotion of the Competition.

1.6 Others

- [1] Any problems that may arise regarding this Rules and Regulations shall be resolved in accordance with the Rules and Regulations of Japanese edition and the Japanese laws. The Organizer reserves the right to make additions, corrections or changes to the clauses in the Rules and Regulations even after the publication.
- [2] Personal information of the applying ensembles collected for these events will be managed by the Organizer and used only for the purpose of managing the events.
- [3] The Organizer shall not be liable for any physical, mental or material damage or injury to the participants arising during the event. The participants are required to subscribe an insurance policy on their responsibilities.
- [4] All performances for the selections will be open to the public at the venue, and be streamed online.

2.1 Eligibility

The Competition is open to ensembles of all nationalities, whose members were born on or after May 18th, 1990.

2.2 Duplicate Application

An ensemble may apply for only one category: Section I, Section II or Festa. Only one application per musician is accepted.

2.3 Reapplication

Any ensemble that has previously won the first prize in the Osaka International Chamber Music Competition cannot apply for the same category.

2.4 Application

Ensembles applying for the Competition should fill out and submit following items through the online application service “MUVAC” (www.muvac.com) which can be accessed from the Competition official website (<https://jcmf.or.jp/competition-festa/>) or (<https://www.muvac.com/competition/japan-chamber-music-foundation-competition>). After submitting your application, make sure that you have received a confirmation e-mail automatically sent from MUVAC.

Application is confirmed as the final upon submission all the items and the payment of application fee specified in 2.5.

- [1] Basic information such as the ensemble name, members' name, base of the ensemble and so on (Refer to MUVAC).
- [2] A recently taken photo of the ensemble, preferably with their instruments.
- [3] A scan of official documents verifying name, birth date and nationality of each ensemble member, such as a passport or a driver's license.
- [4] Ensembles applying for the Competition must submit a letter of recommendation from their teacher or a musician equivalent to the instructor.
- [5] Biography of the ensemble.
- [6] Performance video

- A video must be recorded on or after January 1st, 2025. The recording format must be MP4.

- **Ensembles applying for the Competition** must select and record one complete work from the repertoire listed in [1] for the 1st round, and one complete work from the repertoire for the 2nd Round.

<Note for video recording>

- A video must be taken clearly with one fixed camera and constantly shows the whole ensemble with their instruments.
- Two works can be recorded separately. But all the movements must be played and recorded in one take for each piece.
- A video should be professional recording quality. Applying ensembles should use adequate quality camera and microphone, and adequate room to apply for the international music competition. Low-quality recording may not be judged at the preliminary screening.
- If the recording video camera has the automatic sound adjusting function, turn off this function when recording.
- A video recording must not be edited or processed to improve sound quality.
- The name of submitted video file should be “Ensemble name _ the title of music”.

2.5 Application Fee

Ensembles applying for the Competition must pay 20,000 Japanese yen through MUVAC.

2.6 Application Period

Application will open from April 1st, 2025 through October 12th, 2025.

Online application form will be closed at 23:59 on October 12th in Japan Standard Time. (JST=GMT+9)

3.1 Preliminary screening

Preliminary screening will be held in accordance with the submitted items and performance videos. The results of the preliminary screening will be E-mailed to all applying ensembles by December 31st, 2025.

3.2 Approval of Participation

“Participation Guidelines” containing detailed information regarding participation will be sent to each selected ensemble.

Any change of the ensemble members once the ensemble receives the Approval of Participation are subject to disqualification.

Selected ensembles for the Competition must not receive any lessons from the Competition jury after receiving the Approval of Participation.

3.3 Confirmation of Arrival

Participating ensembles should check in at the designated time, date and place and participate in the briefing. In principle, an ensemble that fails to check in at the specified place on time cannot participate in the Competition.

3.4 Practice Facilities

Participating ensembles of the Competition will be provided with a free-of-charge practice room for three hours a day from May 16th, 2026 during their participation except for performance day. Participating ensembles cannot select a time slot or a practice room.

On the performance day, the rehearsal studio will be available shortly before their performance.

3.5 Performance Order

The order of performance for the 1st Round will be decided by drawing lots at the briefing. The order of performance for the 2nd Round and subsequent rounds will be decided in accordance with the prescribed methods.

3.6 Musical instruments

The participants must prepare their own instruments. However, the Organizer will provide a Concert Grand Piano tuned at pitch of 442 to ensembles participating in the Section II.

3.7 Repertoires

Ensembles applying for the Competition must select works from the repertoire listed on pages 30, 31 or 32. If the ensembles select the works with publishers' names, they must use those editions.

3.8 Judgement

Judgement of the Competition will be made by the jury commissioned by the Organizer in accordance with the judging rules.

Any decision of the jury shall be final and there shall be no appeal against the results.

3.9 Announcement of the Results

The results of the respective rounds will be announced at the venue after completion of the performances scheduled for the day.

4.1 Prizes for the Competition

The following prizes will be awarded to the winners of Section I and II.

First Prize: 2,500,000 yen, Certificate of Commendation

Second Prize: 1,200,000 yen, Certificate of Commendation

Third Prize: 800,000 yen, Certificate of Commendation

“Ambassador Ensemble of the 12th Osaka International Chamber Music Competition” Award

This award will be sent to an ensemble selected from all the ensembles in the Competition. The award-winning ensemble will perform in a concert as an ambassador of the Osaka International Chamber Music Competition in the chamber music festival “Verband der Streichquartette und weiterer Kammermusik-Ensembles VdSQ e.V. & Förderverein Festival4 e.V.” to be held in Germany in 2028. It will be awarded by the president of the VdSQ.

*MK Memorial Special Support

Award-winning ensembles will receive financial support for a part of their travel fee when they join the festival or program of Special Award. The support will be financed from the generous donation by MK Memorial.

4.2 Taxation

The amount of money above is subject to taxation as stipulated in the Japanese tax laws and will be paid in Japanese yen.

4.3 Prizewinners' Concerts

- [1] The prizewinners of each section of the Competition must perform without fee at the concert to be held at Sumitomolife Izumi Hall in Osaka on Saturday, May 23rd, 2026.
- [2] The first-prize winners of each section of the Competition must perform without fee at the concert to be held at Suntory Hall in Tokyo on Sunday, May 24th, 2026. The Organizer will cover travel expenses between Osaka and Tokyo as well as accommodation fee for the night.

4.4 Concert Tours

As part of the prize, the first-prize winners of each section of the Competition will be invited to perform in a concert tour (called Grand-Prix Concerts). They will give about ten concerts to be held across Japan on the following schedule. The performance for the concerts will be remunerated.

First-prize winner of the Section I : Late October through November, 2026

First-prize winner of the Section II : Late October through November, 2027

*Applying ensembles must inform the Organizer if they have any other appointment during these periods when they apply.

4.5 Member change after winning the prize and award

If an ensemble change its member after winning the prize or award, it might be disqualified from the concert tour or the special award.

5.1 Travel Expenses

In principle, all participants must bear their own travel expenses. However, the Organizer will provide them with travel expenses as specified below.

5.2 Participants Residing Outside Japan

The Organizer will provide economy class airline tickets (round-trip) from the international airport nearest to their home to Kansai International Airport or Osaka International Airport. The Organizer will pay for their flights and an extra seat for a cello. Participants must enter and leave Japan using the flight specified by the Organizer.

Participants must bear the expenses for transporting their instruments, except for a cello, to and from Japan.

5.3 Participants Residing in Japan

The Organizer will provide 20,000 yen to the participants residing in a remote area of Japan (300 km or more from the venue).

*The above financial assistance is subject to taxation as stipulated in the Japanese tax laws.

5.4 Lodging Facilities

The Organizer will cover lodging expenses for all participants for the period described below. Participants should stay at the accommodation specified by the Organizer. Expenses for food, transportation, communication, etc., must be borne by the participants.

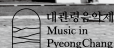
